## Chronology of Manhunt

9:15 a.m. Wednesday, Jan. 24 —Michael Salvi and Abraham Prins escape from state prison guards Joseph Sadovy and E. John Aatrak at entrance to Passaic County courthouse, Paterson. The guards' pistols were taken by the convicts. The prison car stalled. The convicts stole the car of Vincent and Elaine Del Negro of Clifton, kidnapping the two people in it, at a nearby traffic light. Del Negro was ordered to drive to Hackensack but got lost while crossing Paterson into Hawthorne. In Glen Rock, the convicts left the stolen car and the couple, taking \$17 from them.

10 a.m.—The convicts were seen walking on the Erie-Lackawanna railroad tracks in Glen Rock. Walking to Ridgewood, they took a local Public Service bus to Ramsey.  
10:20 a.m.—The two men left the bus at the corner of Spruce and East Main sts. by the First National Bank and Trust Co. They walked to the rear of the Buster Brown shoe store and behind the Shop-Rite supermarket, where they apparently turned south along the Rockland right of way.  
10:50 a.m.—The bus driver, Raymond Migliorino, was stopped in a roadblock in Ho-Ho-Kus and gave positive identifi-

cation of the two men. The search was then concentrated on Ramsey.

3 p.m. — The two convicts were almost captured unbeknown to police officers. Refuge was taken in the Christopher lumber yard as snow began to fall.

7 p.m. — Michael Salvi was captured by Lt. Parenti after he attempted to make telephone calls at the Allendale Spa, West Allendale Ave. Prins was hiding behind concrete parapet at the railroad track, observing the arrest. Shortly after, he entered Brookside School by breaking a window, cutting his right hand and arm. He completed a telephone call and lost two buttons in the school from the stolen brown topcoat he was found wearing at his capture.

8:30 p.m. — Crestwood Lake area was thoroughly searched with aid of floodlights from fire departments and civil defense. Salvi was returned to Allendale in an attempt to make sense from his story. It took three hours for police to get a straight account.

Midnight—Salvi was returned to Passaic County jail.

1 a.m. Thursday — Many of the searchers called it a day. Allendale School entry found. Local police continued to follow every tip.

7 a.m. — Mrs. Shea called from 289 Elizabeth Ave. Sgt. Gates and Ptl. Hancock answered and Gates began to track Prins.

7:30 a.m.—Prins surrendered to Gates in woods between Maple St. and railroad tracks.

9:30 a.m. — Prins was returned to Passaic County jail. Everybody went home to sleep, and Ramsey-Allendale residents breathed a sigh of relief.
