performance of both the police and the fire department during the search is indicative of their fine training.

Mayor Newman extended his thanks to all the citizens who helped in apprehending the escaped convicts, but warned that at time "dogooders" hampered the work of the authorities. In the case of each arrest, however, it was a quick thinking citizen who notified the police.

Ordinances Passed

The council passed two ordinances at the meeting. There was no public interest or discussion concerning an ordinance regulating claims against the borough or an ordinance establishing a fire prevention code. Mr. Morton praised the new fire code as putting the department in a fairer position for control of fires and inspection to prevent fires. Councilman Joseph F. Waldorf explained that this ordinance was passed after the writing of a second draft, in an effort to eliminate difficulties for the borough.

The mayor administered the oath of office to Fire Chief Everett Straut. Full credentials had not arrived in time for the reorganization meeting on Jan. 1, and the swearing in was postponed at that time.

The mayor had a communication from McClave and McClave, engineers, read to the governing body. He did this so that all might hear the clear and complete work the new engineers are doing for the borough. He said he looked forward to a rewarding relationship with the firm.

Mrs. Henry Werner of 8 Cottage Pl. has been selected as the new court and violations clerk. She will serve through December, 1962 at an annual salary of \$1,000.

Budget Hearing Mar. 8

Councilman W. James Hall announced that the borough budget is almost finished and that a public hearing to discuss it will be held on Mar. 8. Mr. Hall said he hoped taxpayers will show some interest before the passage of the budget, not wait and complain afterwards. The assessors indicated a rise in rates of \$300,000. The mayor explained this rise would have been greater had personal property assessments not been deleted from the tax base. This deletion, plus an \$860 tax reduction to elderly citizens, has cut the tax base.

Mayor Newman said that the council had worked diligently to fit the budget to the new tax base and that this year there should be no increase in tax rate. There has been some reduction in appropriations in order to fit the tax reduction.

A neighborhood group was present at the meeting, represented by its lawyer Thomas O'Brien. Included in the group were Roger B. Vanelli, Burchard P. Romait and Talbot B. Dunn, who are concerned about the proposed extension of the Aquarium Supply Co., Cottage Pl. This land is Triple A zone and available only for residential or agricultural use.

Mr. O'Brien questioned whether the proposed buildings were to be for commercial purposes, not for agricultural purposes. Borough Attorney George Winne, who had given the opinion that the additions were of an agricultural nature, admitted that he was no aware of the amount of traffic and number of workers involved in the larger establishment. Mr.

O'Brien asked that all pertinent information be given to the attorney so that the council and the attorney might reconsider the use of this property.

of additional teachers and changing the salary limits for teachers to \$4,700 minimum and \$7,700 maximum and \$26,300 for outside tuition.

More Tuition Students

The increase in the number of students attending Ramsey High School, Bergen Technical High School and Mahwah regional class accounts for \$27,077.95 increase over last year's budget, bringing the total for outside tuition to \$196,800.

Other increases include \$1,475 for capital outlay and \$2,356 for debt service.

Adoption of this school budget means an increase in the tax rate of 94 cents per \$100 of assessed valuation for the calendar year of 1962, representing an approval for the expenditure of \$301,490.82. The other \$276,352.30 to make up the total of \$577,843.12 is the carryover from the budget approved last February.

Voting on the proposed budget will take place Tuesday, Feb. 13.

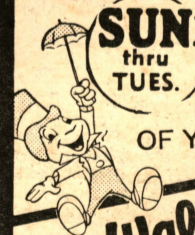
