CRESTWOOD SWIM CLUB

We're off to a racing start: membership registration includes more than half the entire population of the Borough -- a goal that was hoped for but never actually anticipated. So the first order of business is to extend our sincere thanks to everyone involved: the joiners and workers.

Since the Crestwood brochure was mailed early in March, a broader membership policy has been adopted. So that you get the complete picture, we'd like to summarize the entire policy, minus all the rate information. Here is how it goes:

<u>Resident Family</u>: Parents (husband and wife together, single parent or guardian. Children (under 21, single, living at home, and 2 years old by July 1st), applicable only to first three children in family; no charge for additional children.

Individuals: Residents, older than 12 years.

Senior Citizens: Residents, 65 years plus.

Daily Guests: Non-members accompanied by season member at all times.

<u>One-Parent Family:</u> Resident single head of household and one child are considered same as parent couple in Resident Family category.

House Guests: A non-resident who regularly stays in home of a resident member. Guest need not be accompanied by host.

Season Guests: Non-resident relatives of resident family member, (defined as father, mother, son, daughter, brother, sister) together with their spouses and immediate offspring, and in addition, a resident member can sponsor and bring in one non-related family or individual; in the latter case, no daily guests (of the season guests) are permitted.

Borough Employees: Full-time Borough employees, together with immediate families, as if they were residents.

RULES TO SWIM BY

The Borough's swimming hole is bigger this year--and so is the list of swimming "do's and don'ts." If you're a member of the Crestwood Swim Club and somehow missed getting the complete RULES AND REGULATIONS at the Gatehouse, here's a summary of them:

General

Lake Director is in complete charge. Borough takes no responsibility for members' property at the Club. Borough is not responsible for accidents or injuries from members' use of Club. Violation of Club rules can mean membership cancellation and badge recall.

Admission

Only members and guests use Club facilities. Under-nines must be with over-18's. Nines and older: OK alone if swim OK. 25 guests per season for family members. 5 guests per season for individual members. One may be daily guest maximum of 5 times. Members must register their guests. House-guest registration available for resident members. No limit, no fee, for "We Care" kids and others like them.

Identification

Members, guests wear valid badges at Club. Badges not transferable. Daily guests buy daily badges, including non-swimming chaperones of children.

Swim, Dive Rules (Lake Director interprets) Swim, dive in designated areas only. No "wild" or "stunt" diving. No tubes, snorkels, etc. beyond shallows. No big beach items within 12 feet of water. Respectable bathing attire required.

Landlubber Rules (Lake Director interprets) All games subject to OK by Lake Director. All Club appurtenances stay put.

Cleanliness

No litter, contaminants or human wastes in any body of water or stream. Litter and solid refuse go into wastebins. No animals at Club, including water. No person at Club with diseased skin or other parts, including inflamed eyes.

Food and Drink

No glass containers or objects on beach or waterways. No one at Club to be under influence of drugs or excessive alcohol.

General Rules

No fires of any kind unless OK'd. No powered model craft to be operated. Discharge of firearms is prohibited. No explosives or pyrotechnics. No long pointed objects, B-B guns, etc. No loud music or sounds. No disorderly conduct. No gambling. No selling or soliciting sales. Registered autos only, and in designated areas only. Top speed:15 MPH.

Now, with these few rules in mind, we hope all members will enjoy their visits to the Club. If anyone has questions on these rules, they can consult a complete set of them at the Club gatehouse. Or contact the Borough Hall.

P. S. Our Playground Program will start soon, details at the Club gatehouse. No fee for children of Swim Club members, \$5.00 for others. Open to kids from 6 thru 12.

THE BUDGET -- AND YOUR TAXES

Allendale's 1972 Budget is \$363,634 higher than last year, with 85% of the increase due to voter-approved raises in budgets for schools. Here's the way it looks:

For the high school, the big jump was the debt service, up 111%: \$95,362 in '71 up

to \$201,107 in '72. Capital outlays at the mentary school pushed up 69%: \$32,000 '71 vs. \$54,000 in '72, and debt service increase of 39% (\$75,412 up to \$105,014) was the other big contributor to the 13.5% boost noted above.

To pay for it all, the rate of taxation per \$100 valuation had to jump from \$4,21 to \$4.81 (a 14.3% rise that differs from the budget rise because of a slight decrease in ratables, mainly the removal of Crestwood Lake from the tax rolls). Thus, a home valued at \$40,000 will reflect a tax increase of about \$240. A home valued at \$25,000 would be taxed \$150 higher.

WATCHING THE PREMIUM DOLLAR

For the last two years, Allendale's insurance coverage has been greatly improved through the efforts of a two-man, volunteer group consisting of Stiles Thomas and Ed Berggren. They have given much of their time to review the Borough's insurance ~verage, bolstering up the weak spots and gesting such money-saving changes as the combining of coverage for the two school systems.

We'd like to express our appreciation of this work. It's another example of how the volunteer efforts of our residents make Allendale a well-run Borough.
