## PLAYGROUND PROGRAM

This program is a Borough-sponsored "summer day Camp" staffed by competent counselors, and provided for children ages six to 12. The full program includes crafts, games, and possible trips to nearby points of interest. Center of activity is the Red Barn Pavilion, offering shelter from rain and sun. Beyond its grass and play areas are extensive wooded areas for hiking and nature study. See the Calendar and Hours table elsewhere in this brochure for information on dates and times this program will be offered.

Register for this program at the gatehouse of the Crestwood Swim Club Saturday, May 25 and thereafter. Youngsters from families registered with the Swim Club pay no fee; others will be charged \$5.00. There will be a nominal fee charged all registrants for supplies.

## REMEMBRANCE OF THINGS PAST...


### ...AND ANTICIPATION OF THINGS TO COME

Among them: a dock for competitive swimming and boating, two canoes, a Toddler Park, a new chlorination system, and a new athletic field behind the Red Barn (established with the volunteer efforts of the Allendale Athletic Association).

This spring, a nature trail through the wooded area on the west side of the lake will be opened, thanks to the efforts of the Junior Woman's Club of Allendale, with the assistance of Allendale's Boy Scouts and Girl Scouts.

One major improvement planned for this year is the construction of a sorely-needed new bath house.

More improvements are planned, and as in the past, they won't add anything to your taxes; profits of Swim Club operations have gone into Swim Club improvements for two years--with your continued support, we'll repeat!

Weekends and holidays, 12 yrs. or older:	\$1.50

SEASON MEMBERSHIP REQUIREMENTS

Parents: Husband and wife together; or single parent (or guardian) and one child together.

Non-Resident Individual: Immediate relative, as defined under "Non-Resident Family."

Children: Under 21, single, living at home, and age two by July 1st. Fees required for first three children in family (except if one is paired with single head of household, as above, then up to three more must pay). No charge for additional children.

Non-Family: One (1) family or one individual may be sponsored for membership by a resident family or individual who is registered for the season. These persons can be more-distant relatives (i.e., aunt, cousin), or friends. They do not have to be accompanied by the sponsoring family or individual while on the Club premises. But the sponsor is accountable for such members as if they were his family.

Individuals: 12 years, or older.

Senior Citizens: *Either member or older.* At least 65 years old.

*Senior Citizen Couple:*

House Guest: Non-resident who is a regular guest, eating and sleeping in the home of a resident member for at least 14 days. Need not be accompanied by host at the Club.

DAILY GUEST REQUIREMENTS

Borough Employee: Full-time. Can join as if resident, either as family or individual.

Daily Guest: Non-member; must be accompanied by host at all times while entering and occupying Club premises. Host shall be season member of Club. A record of admissions will be kept. Maximum number of guests for each category of season membership is shown below. Thus, the collective total of guest admissions permitted for all who are included in a particular "Resident Family" membership is 12. (If a person holds an "Individual" membership and his family are not members, for instance, the maximum number of guests he may have is eight.)

Non-resident Family: One head of household must be immediate member (father, mother, son, daughter, sister, brother) of a resident family who is registered for the season. Membership available to spouse and offspring. Requirements same as for "Parents" and "Children" as defined herein.

Resident Family/Borough Employee Family: 12  
Resident--or Borough Employee-Individual: 8  
Senior Citizen: 12

Non-Resident Sr. Citizen: Immediate relative, as defined under "Non-Resident Family."

All non-residents and House Guests: none *allowed no guests*

## MEMBERSHIP

Any Allendale resident may join the Crestwood Swim Club on a season-membership basis. There are provisions for non-resident season memberships, too. Only guests will be admitted on a daily fee basis. Requirements for membership and fees are explained on the next page.

Residents and non-residents who aren't season members will not be admitted to use Swim Club facilities on a daily fee basis unless they are "guests" of Swim Club members. The success of the Swim Club is completely dependent on season membership registrations during the pre-season period. To hire guards, buy chlorine, and do the many things required to assure a pleasant, safe swimming facility, we must have an advance commitment.

Everyone is urged to register as soon as possible to take advantage of the low pre-season rates. Please include full payment with your registration, which can be mailed or brought to the Borough Hall. For Non-Resident and for House Guest registrations, apply in person at the Borough Hall. Badges will be distributed at a time closer to the Club opening date.

## CLUB PROGRAM AND FACILITIES

Members of the Crestwood Swim Club, and their guests, will have exclusive use of the lake, diving facilities, and designated beach areas. Canoes will be available to members qualified to handle them. At peak attendance times, three swimming areas will be in use: the shallow beaches on the east and west sides of the lake, and the deepwater diving area for more advanced swimmers and for the diving crowd.

Swimming lessons will be provided at specific times during the season. The instruction will cover the full range of proficiency, beginner classes to Red Cross Life Saving. Information on schedules will be posted at the gatehouse.

The lake in Crestwood Park is artificial, and as such, has a clean, sandy bottom. The lake is chlorinated by a system newly installed and operated for the first time last season. The water is maintained in adherence with health codes and every effort is made to assure the highest level of water quality and safety.
