Allendale Houses and Buildings Built 1940 or Earlier

Introduction and Explanation

This manuscript lists houses and buildings in Allendale that were built in 1940 or before. The date of 1940 was dictated by access to many of the records from a borough-wide tax appraisal done in that year (see more, below). 1940 also seems a good "cut-off" year because, in 1987, as this manuscript is being compiled. houses built that year and earlier are just about 50 years old (or older). In addition, a post World War II building boom in Allendale has probably more than doubled the houses that existed in 1940. To try to include these later homes would have created too burdensome a job!

This project has taken me more than a year of active (though parttime) work, but it incorporates more than 20 year's random accumulation of information about Allendale.

I have tried to be as accurate as possible, but I am sure inaccuracies and omissions have occurred. For these I apologize, and hope that future historians will correct and expand this effort at listing Allendale's older homes.

About Sources

Most of the sources are cited within the narrative of the text. Where sources are not cited, information may have come from local residents' memories.

Very few of the houses listed have been systematically researched, so much of the information is sketchy and incomplete. I hope that this sampling of information will spur interested local historians and homeowners to more fully investigate the history of Allendale's houses.

In sorting "fact from fiction," primary sources are given more credence. Primary sources are contemporary records (recorded at or near the time of the event) and include deeds, tax records, rateables

lists, census records, contemporary newspaper items, directories, rosters, wills, etc.

Early maps that show house locations (sometimes labeled with the owners' names) have proven helpful. Included are:

When property transactions are known, they are cited. The deeds cited are on file at the Bergen County Courthouse in Hackensack. The Book and page number of the deed, when known, is listed in parentheses. A few abbreviations are used:

LW&T = Last Will and Testament h/w = his wife

h/h = her husband

Newspapers cited usually exist on microfilm (with a few exeptions, where a newspaper clipping in either the Allendale Historical Society collection or private collections was used). Complete or long runs of the

following old newspapers are locally available:

The Ramsey Journal exists on microfilm at the Ramsey Public Library.

The Bergen County Democrat, The Hackensack Republican, and The Bergen Record (now The Record) are available on microfilm at the Johnson Public Library in Hackensack.

The [Paterson] Daily Guardian and The [Paterson] Weekly Guardian are available on microfilm at the Paterson Public Library.

The Ridgewood News is available in large, bound volumes (hefty and difficult to use) at the Ridgewood Public Library.

Unfortunately, there are no known archives of issues of Allendale's former newspapers, *The Allendale*

Argus and The Allendale Press (later known as The Allendale Picture Press).

Early Bergen County tax rateables are on microfilm at the Johnson Public Library in Hackensack. This library also houses the Bergen County Historical Society Collection.

The listings are arranged alphabetically by street name. Then, within the street classification, the listings are arranged numerically, from low to high.

The 1940 Borough Tax Appraisal

In 1940, a sweeping reappraisal of homes in Allendale took place. The borough hired an outside firm to conduct the appraisal, which was done in August and September of 1940, by F. A. Tetor.

The Appraisal sheets are preprinted 9-3/4" x 13" forms on which the appraisal information has been typewritten (see reduced-size sample sheet). A photograph was taken of each house or building and affixed to the sheet. An identifying number "sign" was placed near each house, to identify the photos; this number has no bearing upon the street address of the house or building. The numbers were merely used to key the photos to the proper tax sheet.

Rough exterior plans and dimensions were drawn on a preprinted grid on each Appraisal sheet.

These Appraisal sheets were apparently used by the Borough Tax Assessor until about 1956, and handwritten notes concerning annual assessments appear in pencil or pen on the front of every sheet (and other handwritten notes appear on both the front and the back of many of the sheets).

When encapsulating this Appraisal sheet within the narrative for each house, the following devices have been used: Information given in straightforward text indicates primary typewritten information.

{ } information in this type of brackets indicates information handwritten in ink or pencil.

[] information in this type of brackets indicates editorial comments or explanation by this author at the time of this compilation in 1986-1987.

Some observations made while reading the Appraisal sheets as a group:

"Finished" as a description of a basement on these sheets does not have the same connotation "finished basement" has today; on these sheets, "finished" describes a basement with a concrete floor as opposed to a dirt floor.

"Class" categories for residential properties refer to the house structure; they range from "D" to "F" with "plus" or "minus" categories included. These might be connected to Fire Department access (?).

Foundations of the houses can almost be used to date houses. Until about 1915-20, stone was used exclusively as a foundation material. About 1915-20, foundations began to be constructed with cinder block, concrete block, and poured concrete.

Plumbing also can date a house: galvanized iron plumbing was used until about 1925-30, when brass plumbing began to be installed. Beginning about 1935, copper tubing became the desired plumbing.



It is interesting, in view of today's tendency toward multi-baths in residences (it is not unusual for a house in Allendale to have 3 or more baths today) to reflect on changing lifestyles. At the time of the 1940 Borough Appraisal, one bath per residence was the norm (very few houses had no indoor plumbing by 1940), and an additional half-bath or lavatory was unusual.

Please note that names associated with a house do not always indicate ownership; some may be tenants. Also note that some listed owners might not have actually lived in the house--many houses and buildings were and are owned as rental income properties.

Key to layout of building or site information - Page setup ("Page" on reverse shows example)

Note: This manuscript has been arranged so that each house or building begins on a right-hand page, and continues through whatever number of pages are necessary to contain the information and photographs concerning that particular house. This results, in some cases, in blank pages. This procedure was followed so that future information or photographs could be added without difficulty.

Please also note that pages are not numbered, but that each page (front

and back) has an identifying block in the upper left corner.

Houses and buildings are arranged in this manuscript alphabetically by name of street, and then numerically by street number, from lowest to highest.

Following this page are 3 reduced-size sample sheets from the 1940 Borough Tax Appraisal.

Architectural description, if available.

Comments regarding historical or architectural significance of the building or site.


About 1908 William C. Lee and his wife, Mary K. Lee, bought 53 acres of the Storms estate and had this house built at a cost of \$5,000 (Ramsey Journal, Dec. 11, 1908). According to an article in The Sunday News, June 1, 1952, written from an interview with the Lees, the house was originally built as a "summer camp." The Lees lived first in New York City, and when they came to Allendale as year-round residents, they added to the house. They called their many-leveled, dark-beamed home "Clovelly" and filled it with antiques, including fine furniture and a collection of copper, brass and pewter.

Before the development of "San Jacinto Estates" this house had a West Crescent Avenue address.

William C. Lee was a vice-president with Bankers Trust Company of New York. He was organist for both the Old Baptist Church of the Epiphany and the Park Avenue Presbyterian churches in New York, and later was organist for the Allendale Church of the Epiphany for 28 years. He was a charter member of the Allendale Fire Association, serving on its board of trustees in 1910 and serving as vice-president in 1912.

Both Mr. and Mrs. Lee were actively involved with the library in Allendale. He was active in the Allendale Library Association, serving as vice-president. After a quarter of a century of operating out of rooms in the borough hall and rented store buildings, in 1926, with funds raised through public donations, the first library building was erected at 353 Franklin Turnpike (SW corner of Franklin Turnpike and W. Allendale Avenue).

In 1941, Mr. and Mrs. Lee donated an addition to the library building (the Mary K. Lee room). Mrs. Lee served as the Allendale Library's volunteer librarian for more than 30 years. In December 1952, after the death of Mr. Lee, the board of trustees changed the name of the library to the "Lee Memorial Library," in his honor.

Frank S. Merrill was born in New York City, August 15, 1864, the son of Charles R. Merrill and Elizabeth Millbank Wall.
