Ho-Ho-Kus

A summons was issued to a Brick Lane resident for having a security device that issued more than three false alarm reports to police. The summonses are being issued as a result of a change in borough ordinances following more than 500 false alarm calls to police in 1989. The ordinance is aimed at encouraging proper installation, registration and maintenance of the devices.

Shoulder stone was dumped at a con-

struction site on Hollywood Avenue Feb. 5, partially obstructing the thoroughfare. The company was contacted to remove the debris at 3:30 p.m. They responded that the company that ordered the stone should be contacted.
