# LIMITED LAWN WATERING REINSTATED

Limited lawn watering has been reinstated for Borough residents, following the schedule which was in place prior to the total ban - West side, Monday and Thursday; East side, Tuesday and Friday, from 5 a.m. to 8 a.m. and 5 p.m. to 8 p.m. There is no watering allowed on Wednesday, Saturday or Sunday. The limited schedule replaces the total ban which was put into place on July 19th. The total necessary due to record ban was consumption, and the inability of the water system to keep up with the demand.

Allendale has two sources of water: three wells within the Borough, and a contract with Ramsey who purchases water from Mahwah. The water coming from Ramsey and Mahwah is also coming from wells. In addition, the Borough has two storage tanks which hold a combined 1.4 million gallons. The water storage tanks control water pressure, and supplement the supply when there is heavy demand. During this high use period, the reserves in the tanks were reduced to fifty percent, which affects both the water pressure, and in a worst case, the ability to fight a fire.

Many residents question why lawn watering cannot take place overnight, since it would seem that the demand would be low. The low use periods allow the Water Department to re-fill the storage tanks in preparation for the following day's demands.

# STUDY OF WATER UTILITY UNDERWAY

The Mayor and Borough Council has authorized a study of the Allendale Water Utility, focusing on potential sources of additional water, and the operations of the Utility. The Water Committee interviewed six consulting firms, selecting the firm of Hazen and Sawyer, which is a recognized and experienced authority in water The study, which began in operations. June, and is to be completed in four months, will provide the Governing Body with options and costs for providing a sufficient supply of water to the residents of Allendale. It will also address the possible rehabilitation and treatment of three contaminated wells on New Street, and treatment options for complying with the proposed Environmental Protection Agency (EPA) regulations for radon in the three operating wells.

## HEALTH SERVICES REGIONALIZED

Sanitary inspections of restaurants and food stores are now being performed by an inspector from the Borough of Bergenfield, under an Inter-Local services agreement. The Borough will also use the Bergenfield Health Officer beginning in 1992. This new arrangement will result in a \$3400 savings in the 1992 budget.

# ADDRESSING CONCERNS ABOUT RADON

Recently, an article appeared in The Sunday Record discussing radon in water. Radon is naturally-occurring, and unlike organic chemicals (gasoline, cleaning solvents, etc.) found in ground water, radon always has been in the water. It is only recently that water utilities around the country have begun to test for radon, and most ground water supplies are likely to find levels between 300 and 1,000 pCi/L. Certain areas of the country, New England, eastern Pennsylvania, western New Jersey, and the western mountain states, are likely to find levels of at least several thousand pCi/L and higher.

Radon in drinking water poses a risk when it enters the air, contributing to indoor radon levels, or when it is consumed. It is released from drinking water into indoor air through running tap water, clothes and dish washing, and showering. The transfer of radon from drinking water to indoor air results in very low indoor air levels for most ground water systems, including the Allendale system. It takes 10,000 pCi/L of radon in drinking water to release 1 pCi/L to indoor air. The EPA action level for indoor air radon is 4 pCi/L. Therefore, for the radon levels found in our water, the release to indoor air represents a very small contribution (less than 0.1 pCi/L) compared to acceptable indoor air levels.

When put into perspective, radon in drinking water is not something new. It represents one more drinking water item which EPA plans to regulate. The health risks associated with drinking our water are very low. EPA is seeking to reduce the risk to as low as is technically and economically feasible. The Allendale Water Department is working towards meeting this very low requirement for radon.
