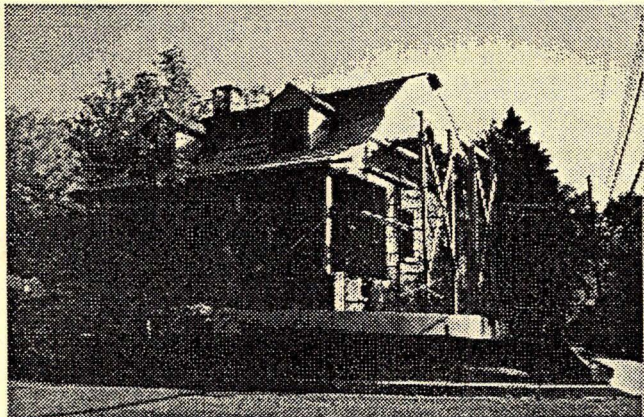

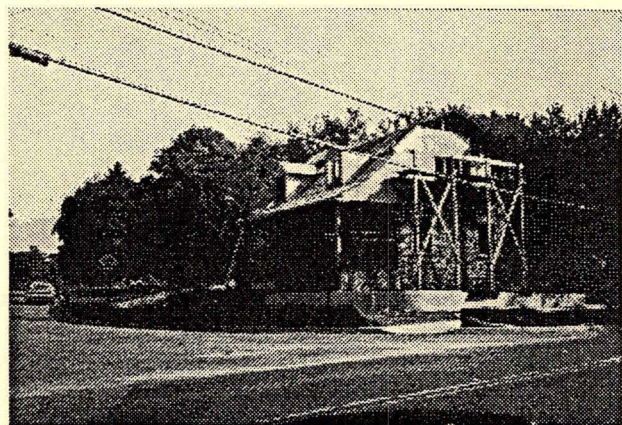

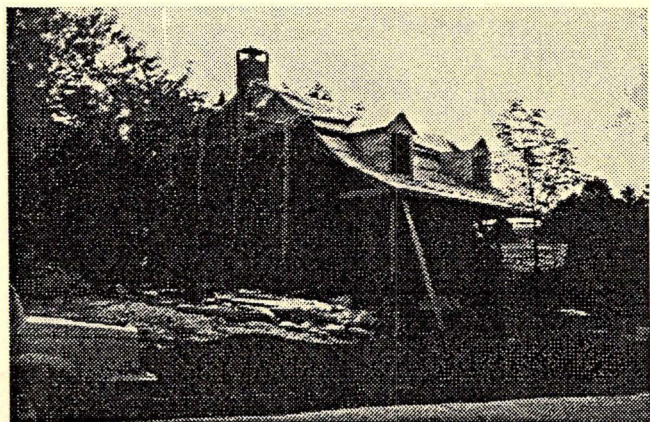
*Ackerman-Rozmus House, Franklin Turnpike

Allendale Fire Department Minstrels of 1951

April 6 & 7, 1951 at Brookside School



ALLENDALE HOUSES BUILT BEFORE 1940

Compiled by Pat Wardell

Compiler's Note: This "inventory" of pre-1940 Allendale houses has been compiled using information in the Society's files and in my own files. Very few of the houses have been systematically researched, so we know that for most of them, the information is incomplete. We would welcome any additions, corrections, updating, etc. from our readers, and will happily add such information to the Society's files.

Only houses still in existence today are included in this inventory. Houses are generally named for the earliest known owner/occupant. Names associated with a house are not necessarily always owners; some may have been tenants. Also, not all owners actually lived in houses they owned; some houses were leased for rental income. The houses are listed alphabetically by street names, then numerically by house number.

151 East Crescent Avenue

Whitelaw House

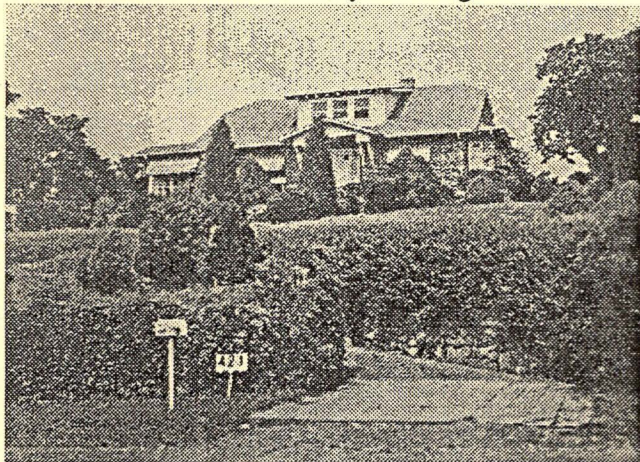
Block 504, Lot 4 (Old Block 51, Lot 46 & 41A)

Built about 1920-25.

Albert Whitelaw and Alitze E. Whitelaw, 1940. Alitze Emma Whitelaw, widow, ?-1960. John C. Lawrence and Aline V. Lawrence, 1960-1962. Charles S. Zern and Ruthann T. Zern, 1962-1965. H. England Benton and Iolanthe M. Benton, 1965-?.

In 1940 the house was described as a 1-1/2 story, frame and stone dwelling with a 22' x 22' garage on a 105' x 297' plot (later 210' x 297'). It was built on a concrete foundation, with a stone exterior and composition shingle roof. There were six rooms, including three bedrooms, a toilet room, and one half-tile bath.

In the 15 Feb 1962 transaction, the description of the land mentioned "lands now or formerly of John Duer; lands now or formerly of the heirs of Patrick Garwin; lands now or formerly of George Hannema."



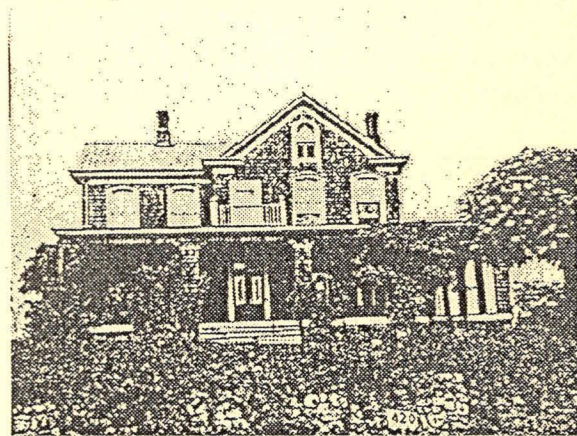

Wilson/Gamble(?)/Arlt House
Block 504, Lot 5 (Old Block 51, Lot 41)
Built about 1865.

Max Paul Arlt, c. 1910. Crescent Hill, Inc., 1940. Max P. Arlt, 1947-48 Bergen-Passaic Telephone Directory. W. Lincoln Fogarty (1985-86 Here's Allendale).

This may be the James J. Gamble House, marked "Jas Gamble" on the 1887 Driving Chart, or it may have originally been a Wilson family homestead. The Allendale Girl Scout Old House File (at the Allendale Library) says the house was "originally owned by the Wilson family. When Grandfather Wilson was a young lad, he owned a race horse. While ill and in bed pining for his horse, the horse was brought into the house, through a side door, through the kitchen and small hallway to a downstairs bedroom where young Wilson was. Beautiful parquet floors with applewood inlay in dining room."

More research would probably determine the pre-1910 history of the house.

James J. Gamble married, December 11, 1869, Margaret Ann Pulis, daughter of Abram Pulis and Margaret Straut. The Pulis property probably at one time was contiguous to and/or included this property. More research needs to be done to resolve the history of this house.

The Arlt family was living here by 1911, when Augusta Arlt graduated from the Allendale grammar school.

Max Paul Henry Arlt, the son of Frederick William Arlt and Augusta Wohl, was born in Breslau, Germany on Nov. 3, 1869 and married, Nov. 2, 1893, Katherine Jane Stagg (b. Lodi July 26, 1869). Arlt came with his family to New York in 1882. He graduated in 1890 from Coleman Business College; in 1915 he organized the American Pharmaceutical Co. and later he began a private law practice in New York and Paterson. Max P. Arlt and Katherine Jane (Lillian?) Stagg had children: Raymond Paul Arlt (m. Felicitas Marie Weiss), Ernest

William Arlt (m. Ethel Allen), Augusta Arlt (m. Carl Wagner), Gertrude Arlt (m. Harold Fox), and Blanche A. Arlt (m. Harry Gee). Raymond P. Arlt, remembering his father in 1983 wrote: "He often accompanied State Police on raids during prohibition. He loved his 106 acre farm and animals."

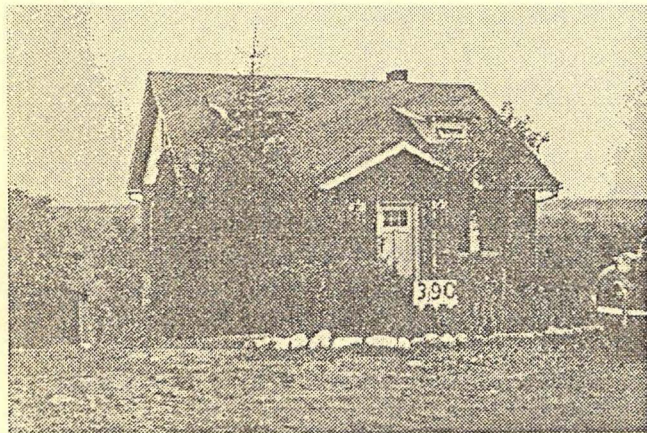
Megnin House

Built 1925 for George E. Megnin.

George E. Megnin, 1925-1957. Marie O'Neil, 1957-1961. Melvin E. Sherrow and Anna May Sherrow, 1961-?

In 1940 the house was described as a one story, brick dwelling with a one car garage on a 110' x 213' plot. It was built on a concrete foundation, with a brick exterior and composition shingle roof. There were six rooms, including three bedrooms, and one wood and plaster bath.

Falk House

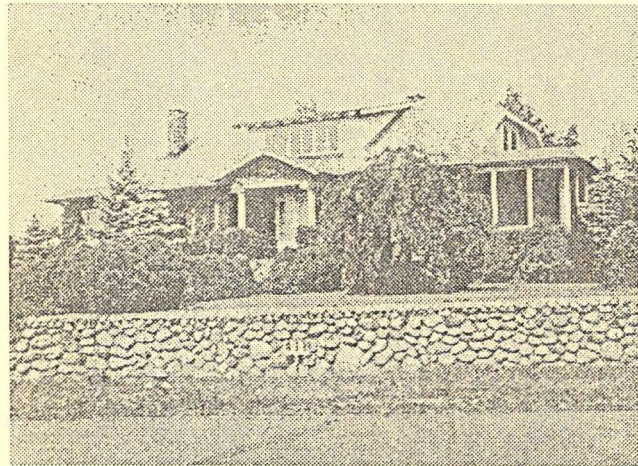
Block 506, Lot 2 (Old Block 52, Lot 2)

Built about 1927.

Frieda Falk, 1940. Caroline Mead Kunze and Bessie A. Meade Kunze, 1945-1950. Aarold G. Asp and Alice K. Asp, 1950-?. Barry Poskanzer and Susan Poskanzer, 1986.

In 1940 the house was described as a 1-1/2 story, one family, frame and stone dwelling with a 24' x 37' 6" garage (a note indicates there was running water in the garage, where there was a sink). The house stood on a 201' x 242' plot. It was built on a poured concrete foundation, with a stone and stucco exterior and composition shingle roof. There were nine rooms, including five bedrooms, two full tile baths and one stall shower. There was a full tile kitchen. The house was sold, along with Lot #7, in 1945 for \$17,000.

The house was sold by the Poskanzers 5 April 1986 for \$444,000. The Northwest Board of Realtors listing sheet at that time described the house and a fieldstone colonial with four bedrooms and three baths. The first floor had an entry foyer, a living room with fireplace, a dining room, a library, a modern kitchen and breakfast room, family room, and a bedroom. There was a circular deck. On the second floor were a master bedroom with cathedral ceiling, two other bedrooms and two baths. The full basement had a laundry and workshop. There was a two car garage, with an office over the garage with a half-bath.

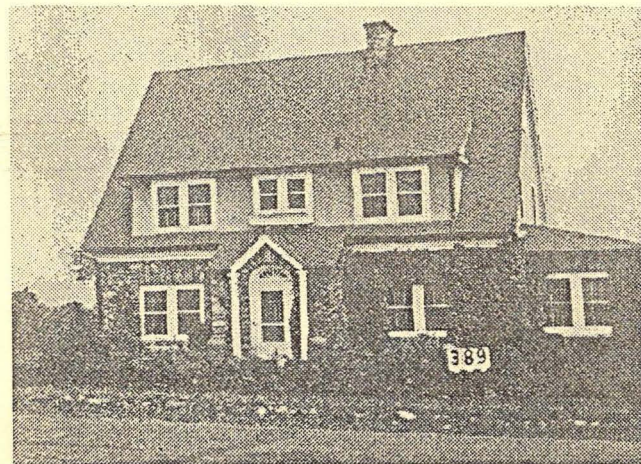
Arlt House

Block 507, Lot 5 (Old Block 53, Lot 5; later Block 53A, Lot 105)

Built 1931.

Ernest W. Arlt, 1940. Phil J. Weimar and Olga H. Weimar, 1951-?

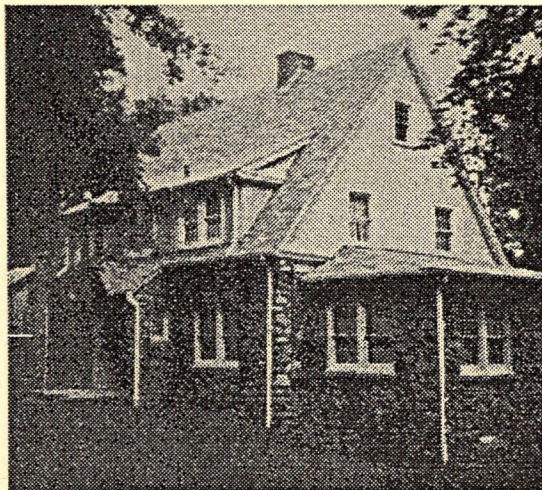
In 1940 the house was described as a two story, frame dwelling on a 112' x 180' plot (a later note gives

lot size as 100' x 220'). It was built on a concrete foundation, with a stone and stucco exterior and composition shingle roof. There were seven rooms, including four bedrooms, a sun room, a toilet room with tile floor, and one bath with tile floor.

Compare this house to the one at 67 Arlton Avenue (Block 506, Lot 7 & 8). They are of very similar stone Arts & Crafts style construction. This one was built in 1931 and #67 Arlton was built about 1928; they may both have originally been Arlt family houses, and may have been constructed by the same builder.

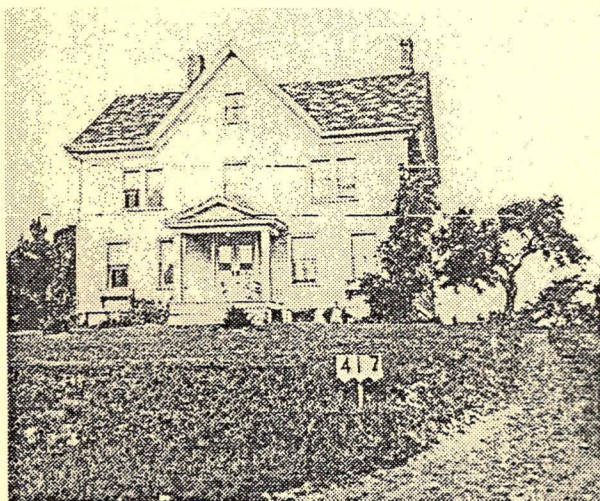

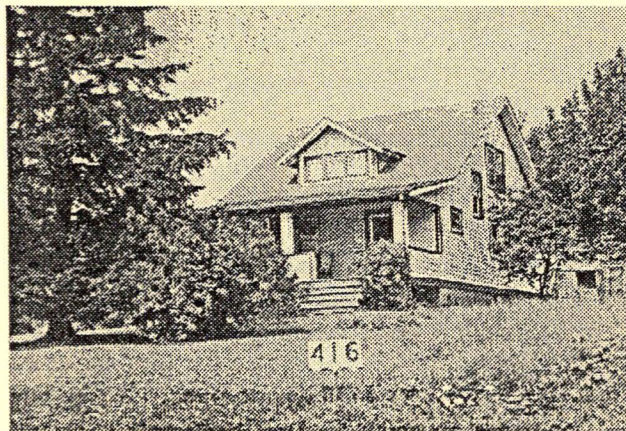

Built about 1925.

Margaret Gamble, 1940. Josephine Sieczkowski, 1944-1944. Alexander Bandurski and Julia

Bandurski, 1944-?. Hosey A. Gamble and Dora Carlough Gamble, ?-1962. Dora Carlough Gamble, 1962-?.

In 1940 the house was described as a 1-1/2 story, frame house on a 268' x 685' lot (4.22 acres). The house had a concrete block foundation, clapboard exterior and a composition shingle roof. There was a 24'6" x 16' barn (assigned no value in 1940), and the house had a bay, an open porch, and an extension. There were six rooms, including three bedrooms, and one wood & plaster bath. A garage was added in 1944-45.

This property was probably part of the larger Gamble farm, probably even earlier belonging to the Pulis family (see also #175 East Crescent Avenue) and likely was deeded to Hosey A. Gamble by his father, James Gamble.

According to the 1880 Federal Census, James Gamble was born on Long Island, NY about 1849. He married Margaret Pulis on 11 Dec 1869. The *Ramsey Journal* in its Dec. 18, 1919 issue, described their 50th anniversary celebration: "A very enjoyable evening was spent by friends and relatives last Thursday evening at the home of Mr. and Mrs. James Gamble on Crescent Avenue, Allendale. The home was very prettily decorated with ferns, with gold and white as a back ground. Durring the evening dinner was served by caterer Gulliver and wife. Striking instances are that two of the guests, George H. Hossey, age 87, and Mrs. Ella Storms, age 80, attended their wedding fifty years ago, and that the bride was born on the same farm sixty-nine years ago, where the Golden wedding was celebrated. The bride and groom received many

gifts including many gold pieces. Those present were: Mr. and Mrs. Hossey Gamble, Miss Dorothy Gamble, Archibald Gamble, Mr. and Mrs. Garry Quackenbush, Miss Katherine Quackenbush, Mr. and Mrs. W. Wilson, Mr. and Mrs. Fred Koster, Miss Evelyn Koster, Mr. and Mrs. G. Miller, Jack Miller, Mrs. Ella Storms, Jerrimire Straut of Allendale; Mrs. E. Winter, Mr. and Mrs. H. Snyder, Mr. and Mrs. J. D. Carlough, George F. Hossey, Mr. and Mrs. C. Secore, James Secore, Winfred Secore, Harold Secore, Cornelius Secore, Mrs. M. May, and Rev. Beach, of Ramsey; and Mr. and Mrs. C. Shuart, of Mahwah."

Hosey A. Gamble, son of James Gamble and Margaret Pulis, married 3 Oct 1896 Dora Carlough, daughter of Mr. and Mrs. James D. Carlough.

Fox House

Block 507, Lot 2 (Old Block 53, Lot 2; later Block 53A, Lot 102)

Built 1934.

Harold H. Fox and Gertrude Arlt Fox, 1934-?

In 1940 this house was described as a one story, one family frame dwelling with a two car garage. It stood on a 110' x 180' plot. It had a porch and extensions. It was built on a concrete block foundation, with a wood exterior and composition shingle roof. There were five rooms, including two bedrooms and one tile floor bath. A garage was added in 1944-45.

Built 1933.

Wilbur Ramsey Goetschius and Grace Hubbard Goetschius, 1932-1967. Benson Scotch and Barbara E. M. Scotch, 1967-?

In 1940 the house was described as a two story, one family frame dwelling on a 110' x 180' plot. It was built on a concrete block foundation, with a stucco exterior and a slate roof. There was an open porch and a garage extension. There were six rooms, including three bed

rooms, a toilet room, and one half tile bath.

Washburne-Doty House

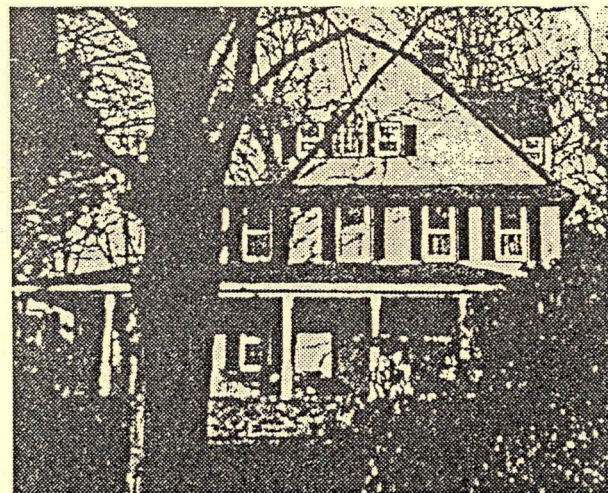
Block 1802, Lot 2 (Old Block 28A, Lot 52)

Built about 1885.

Edward Grant Washburne, c. 1907. Washburne, 1940. Percy Southwick Doty, c. 1943. John Washburne Doty, c. 1947-1951. Joseph F. Schulz and Claire M. Schulz, 1951-1964. David K. Silver, 1964-?

Edward Grant Washburne was born in New York City October 30, 1864. He married Pauline Fisher (Fischer?).

The Washburnes lived on Island Avenue in Ramsey before moving to Allendale about 1907. E. G. Washburne was one of the founders of St. John's Episcopal Church in Ramsey, and in Allendale was superintendent of the church school of the Church of the Epiphany Episcopal Church for 46 years. He was also active in the Allendale Library Association, and was president of the Association at the time of his death in 1943. Percy Southwick Doty married Mildred Washburne and they were living here by 1943, when her father died.
