In the currently running series in this newsletter on Allendale Houses Built Before 1940, the house labeled "85 Elmwood Avenue," on page 5 of the February-March issue, should be labeled "83 Elmwood Avenue. The data for the house remains the same except that it applies to 83 Elmwood Avenue, not 85 Elmwood Avenue, and the house was sold by James F. Creelman to Al Werner. Mr. L. Colaianni, who lived until recently at 85 Elmwood Avenue, called to advise us of the error and we appreciate the correction.

Both the society and your editor appreciate hearing from all those, near and far, interested in Allendale. Preliminary meetings of representatives of some of Allendale's clubs and organizations have been held to begin to formulate a committee to plan and organize events commemorating the 1994 centennial anniversary of the incorporation of Allendale as a borough.

Many other Bergen county communities organized in 1894, following legislation that permitted communities to adopt a borough form of local government. Previously, except for a few cities in Bergen County, the local-level governing bodies were larger townships. These townships were generally comprised of several neighborhoods or localities each of which were now free to organize themselves as boroughs. So 1994 and 1995 will see the centennial celebrations for not only Allendale, but numerous neighboring boroughs as well. Included in this issue is the story of Allendale's incorporation.

Allendale Becomes a Borough: The 1894 Incorporation Story

On March 12, 1890 New Jersey legislation was enacted permitting the formation of boroughs and their "general incorporation by Election." Before this, most local government within Bergen County was the township form of government.

In Allendale, the proposal to build a new school to be located within Orvil Township in what is today Waldwick (instead of at Allendale, where the previous schoolhouse had been) made Allendale residents rise up to promote the idea of a separate local government.

A petition dated September 17, 1894 called for a special election to propose the question of formation of a borough named "The Mayor and Council of the Borough of Allendale."¹ This petition was signed by owners of at least 10% of the taxable property within the boundaries of the proposed borough, who encompassed parts of Orvil, Hohokus, and Franklin Townships. Signers of the petition were:

Citizens and property owners of Orvil Township in proposed borough: R. V. Ackerman, O.H.P. Archer, J.A. Mallinson, William H. Mallinson, and Louise Doty.

Citizens and property owners of Franklin Township in proposed borough: Louis Rossner.

Citizens and property owners of Hohokus Township in proposed borough: R.V. Ackerman, Peter D. Rapelje, Garret G. Smith, John A. Mallinson, and William H. Mallinson.

In response to the petition, on October 16, 1894, Bergen County Common Pleas Judge James Van Valen ordered that a special election be held at Archer Hall in Allendale on November 8, 1894 to enable qualified residents to vote for or against the incorporation of the borough. Judge Van Valen appointed Alfred E. Ivers Clerk of the Election, and William H. Mallinson and Joseph H. Ware as Inspectors of the Election.

On October 20, 1894 Joseph H. Ware, Election Inspector, posted ten notices of election in the following locations within the limits of the proposed borough:

1. One on a post in the Post Office at Allendale.
2. One on a wall in the gentlemen's waiting room in the depot at Allendale.
3. One on a post in R.V. Ackerman's grocery store in Allendale.
4. One on the public bulletin board on the southwest corner of Allendale Avenue and Franklin Turnpike in Allendale.
5. One on the gate post in front of the school house at Allendale.
6. One on a guide post on the northwest corner of Allendale Avenue and Chapel Street², at Allendale.

7. One on the door (outside) of Zabriskie's blacksmith shop on Allendale Avenue, in Allendale.

8. One on the outside of the door of Bullis's [sic] blacksmith shop on the Franklin Turnpike near Allendale. [Should read "Pullis's"]

9. One on the front of Burtis's Feed Mill on the road leading from Allendale to Wyckoff.

10. One on a telegraph pole situated on the road leading from Allendale to Wickoff [sic] near the barn of R. V. Ackerman.

On November 8, 1894 the certificate of election was signed by Alfred E. Ivers, Clerk of Election, and William H. Mallinson and Joseph H. Ware, Election Inspectors. According to the certificate: "The whole number of ballots was one hundred and eleven of which one hundred votes were for incorporation and eleven votes were cast against incorporation, giving a majority of eighty-nine votes for incorporation."

On November 10, 1894 proceedings for the incorporation of the Borough of Allendale were filed and recorded by Samuel Taylor, Clerk.³

Election Postscripts: Allendale's schoolhouse (today's Police Headquarters) was built in 1896; and in 1915 an additional section of Franklin Township was added to Allendale. ■

Notes:

1. The lengthy name form, "The Mayor and Council of the Borough of Allendale" was the borough's legal name until 1903, when the official name became "The Borough of Allendale." Some other boroughs created in 1894 also had this lengthy form of name, including "The Mayor and Council of the Borough of Glen Rock."

2. Chapel Street, today Cottage Place, was named for the Chapel in the Willows (Epiphany Church) which stood on the southeast corner of this intersection until it was moved to the southeast corner of Franklin Turnpike and Orchard Street.

3. November 10, 1894 is the date the action became effective. In dating municipalities, the *effective* date sometimes differs from the *approved* (or election) date (as in Allendale's case). The effective date is generally considered the legal and official date.

Note that several of these students grew up to be Allendale Historical Society members (and one is the father of this editor).

Local "News" from the Ramsey Journal. . .

Nov. 13, 1896 — Saddle River — Mr. Wm. Zabriskie went to Paterson with a load of produce last Saturday and while making his deliveries some one stole a basket containing eight pounds of butter and several letters.

April 7, 1899 — Hohokus — When the carpenters tore down the store end of the Bamber homestead, which is being remodeled, they found 73 old copper one cent pieces which date from 1803, and a bag containing 57

very old three cent pieces. It was this end of the building that the Bar used to be, when railroads were unknown in Jersey, and when coaches were the means of transit, this place used to be a "Change Horses" Station. All you who have been in the Wild West know what that means, and for those that have not we would say its where the horses are exchanged for fresh ones so that the coach has as little delay as possible. Probably there are very few people living in this place that are aware that this old mansion is nearly two hundred years old.

ALLENDALE HOUSES BUILT BEFORE 1940

Compiler's Note: This "inventory" of pre-1940 Allendale houses has been compiled using information in the Society's files and in my own files. Very few of the houses have been systematically researched, so we know that for most of them, the information is incomplete. We would welcome any additions, corrections, updating, etc. from our readers, and will happily add such information to the Society's files.

Only houses still in existence today are included in this inventory. Houses are generally named for the earliest known owner/occupant. Names associated with a house are not necessarily always owners; some may have been tenants. Also, not all owners actually lived in houses they owned; some houses were leased for rental income. The houses are listed alphabetically by street names, then numerically by house number.

18 First Street Ackerson House

Block 1709, Lot 3 (Old Block 17, Lot 13)

Probably built between 1861 and 1876.

"R. Ackerson" on 1876 Walker's Atlas (detailed map of Allendale Railroad Station district).

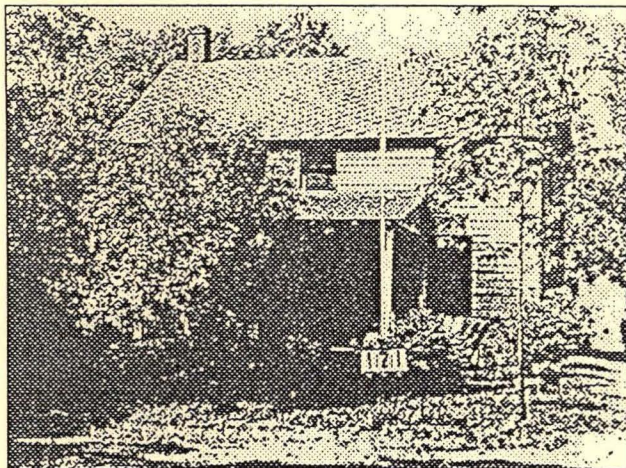

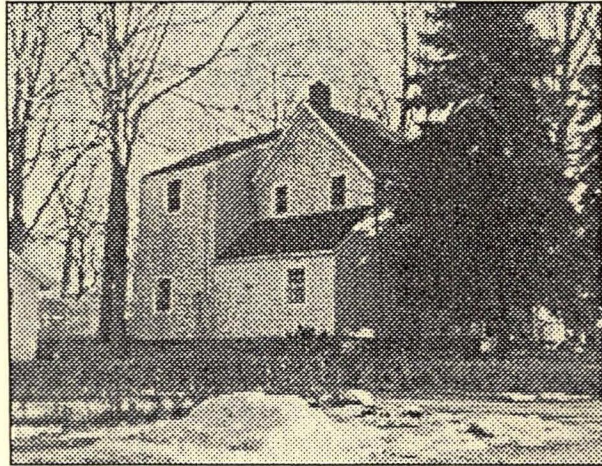

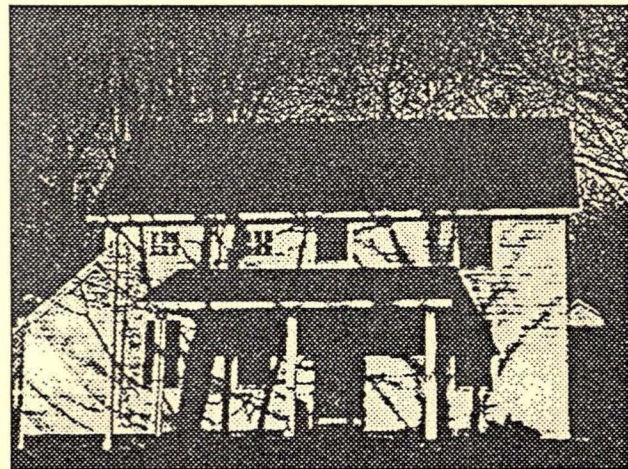
The Bergen County Historic Sites Survey (1983) describes the house as erected between 1861-1876. On the south facade, first & second stories there are 4 bay windows. There are gables and on the south facade there is a 2 bay porch with post supports and a shed roof. A rubblestone foundation is visible. A one-story wing at the southwest corner has a rubblestone foundation. Alterations include replacement exterior siding, some replacement window sash, south porch, and a two-story wing added at north rear. The county survey considers this house part of the "Allendale

Railroad District" and discusses this house as building #2.

Ryerson Ackerson was born about 1840, married Rachel -?-, and died in February 1925. Rachel was born about 1845 and died in 1917. Ryerson Ackerson was a mason and later a house painter. They were living in Allendale by 1880, when their family was listed in the 1880 Federal Census. Ryerson Ackerson was elected a Commissioner of Appeals at Allendale Borough's first election in December 1894.

Ryerson and Rachel Ackerson had 9 children, 7 of whom were still living in 1917 (6 still living in 1925). Their children included: Charles Ackerson, b. about 1865 (m. Hattie -?-); Jacob Ackerson, b. about 1868; Anna Ackerson, b. about 1870 (probably m. Charles Sinell); Roland Ackerson, b. about 1872 (m. Elizabeth -?-); John Ackerson, b. about 1875 (m. Bessie -?-); Milton (Mills) Ackerson, b. 1881 (m. Frances Mulray); and Lucy Ackerson, b. after 1880.

There is a house marked "S. Roswell" in approximately this location on the 1876 Walker's Atlas Map. Further research needs to be done on the history of this house.

The Bergen County Historic Sites Survey (1983) calls this the "Smith Roswell House, built 1861-1876." The Survey describes the house as residential, a vernacular Downingsque cottage. It has punched undulating vergeboard in south gable and east-west gable ends. There are pointed attic windows in the gable and gable ends. Alterations include replacement synthetic shingles, enclosed and glazed south porch, and a one-story addition at the north rear.

Smith Roswell was born on February 26, 1827 at La Grange in Dutchess County, New York. He died September 24, 1910 and was buried in the Union Cemetery, Waldwick. He married on July 3, 1853, Ellen McKinsey Bull, who had been born about 1836 and who died February 23, 1923. They had children: Sarah E. Roswell, b. abt. 1855 (m. Joseph Steele); Charles Smith Roswell, b. 1857 (m. Emma Langwith); Edgar L. Roswell, b. February 1, 1861, d. December 28, 1880; Ingham I. Roswell, b. December 7, 1862, d. December 4, 1887; William Roswell, b. abt. 1870, d. March 1954; and Eva M. Roswell, b. abt. 1876 (m. Rev. John R. Winans).

Smith Roswell came to Allendale about 1848 (with the railroad) and by June 1859 he had been appointed station agent at Allendale by the Erie Railroad. As early as 1859 he was running a general store in Allendale, and about 1857-58 he was appointed postmaster of Allendale at a salary of \$12 a year.

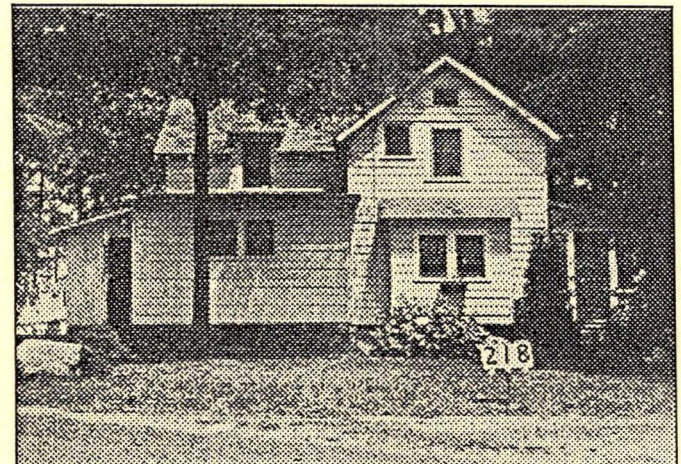
Early history of the house not known at this writing. Probably the house was in the Ackerson family.

In 1940 this house was described as a two story frame dwelling with extensions, a bay, and a sun porch. It had a clapboard exterior and a composition shingle roof and was built on a stone foundation. There were 5 rooms, including 2 bedrooms and there was one wood and plaster bath. At one point, probably in the 1940s, it was rented to Albert Lockwood.
