LESLIE R. JOHNSON, MAYOR OF ALLENDALE

Leslie R. Johnson was born 7 April 1905 in Orange County, Indiana, and died 8 November 1983 at Kansas City, Missouri. He married on 14 July 1931 Mary Eliza Elliott from Washington County, Indiana.

His obituary appeared 9 November 1983 in *The Kansas City Times*:

Leslie Richard Johnson, 78 of 5433 Mohawk Lane, Fairway, a former executive of American Telephone & Telegraph Co., died Tuesday at St. Luke's Hospital.

Mr. Johnson worked for AT&T for 44 years before he retired as chief engineer of the Long Lines division Midwest area in 1970. He received a bachelor's degree in electrical engineering from Purdue University in 1928 and was a member of Sigma Xi, Eta Kappa Nu and Tau Beta Pi. He

was mayor of Allendale, N.J., from 1950 to 1952.

Mr. Johnson was a member of the Telephone Pioneers of America, the Institute of Electrical and Electronics Engineers, the American Association for the Advancement of Science, the Society for American Archaeology, the American Anthropological Association, the National Rifle Association and a Masonic Lodge.

He was born in Leipsic, Ind., and had lived in this area since 1956.

He leaves his wife, Mrs. Mary E. Johnson of the home; two sons, Tem E. Johnson of the home and Dr. Eric Richard Johnson, Lake Quivera; two brothers, James W. Johnson, Huron, S.D., and Norman E. Johnson, Leipsic; a sister, Mrs. Mary Whiteman, Syracuse, Ind.; and three grandchildrenburial in Johnson County Memorial Gardens Cemetery.

GROWING UP IN ALLENDALE

I lived in Allendale for 19 years. My grandfather, Henry Buthfer, who married Anna Nehmelhman, had a business in New York City, but he insisted that his wife and daughters spend their summers in New Jersey in Allendale. He and his wife had three sons who died as infants, and then they had five daughters:

- Marie Dorothea Buthfer, b. New York; d. 1922 NJ; married Harry C. Hartt.
- Clara Henrietta Buthfer, married Clarence Cooper.
 - Josephine Buthfer, died at the age of 19.
 - · Anna Adele Buthfer, married Logan Noyes.
- Elsie Wilhelmina Buthfer, married Edward Watkins.

They all raised their families in Allendale, and the sisters all died there.

In 1911 Harry C. Hartt and Marie Dorothea Buthfer Hartt moved from New York City with Henry Buthfer Hartt, three years old, and Rosemary Clara Hartt, not a year old, to a Franklin Turnpike residence across from Cockcroft's and Tamburella's (my piano teacher), below Robert Phair's home. We stayed there until 1926. Around 1920 Marie Dorothea inherited from her grandmother, Mrs. Wilhelmina Nehmelhman of New York, and she put in electric and plumbing — doing away with the pump, etc. Clara Cooper did the same for their home on West Crescent Avenue.

Harry C. Hartt died in Santa Barbara, California on April 24, 1967 after retiring from Bloomingdale's in New York City in 1963.

My brother, Henry Buthfer Hartt, was born

July 1908 in New York City and attended Allendale Grammar School and Ramsey High School. He died in Baltimore, Maryland in 1935 at the age of 27, leaving his wife Ernestine, and son Quintin Hartt, age 6. Quintin now lives in Chopin, Louisiana.


I was born on April 21, 1911 in New York City on West Street. When I was nine months old we moved to Allendale. I graduated from the Allendale Grammar School in 1925. I then attended Ramsey High School for two years and received Medals and a Track Letter in Running. I left school to go to work in New York City for the Telephone Company in 1927. I travelled to work on the Erie Railroad and lived with Aunt Clara and Uncle Clarence on West Crescent Avenue.

My sister Josephine was born in our home on Franklin Turnpike in 1914 and died at the age of three.

My brother John Marshall Hartt also was born at home in Allendale in 1917 and died April 22, 1974 in Pleasanton, California. He married Jessie Michaelson December 5, 1941. They had one daughter, Susan Hartt (married Robert Perolito), who lives in Pleasanton, California.

My brother Richard Buthfer Hartt was born at home in Allendale in 1919 and now lives in Ocala, Florida with his second wife, June. His first wife, Carmella Mele died in Troy, NY in 1985. They had two children, Richard who lives in Troy, NY, and Christine Hartt Henschens, who lives in Fort Wayne, Indiana.

My aunt and uncle, Elsie and Edward Watkins, had five children and lived in Allendale. Another

aunt was Anna Buthfer, who married Logan Noyes and had a daughter Lorna, born September 9, 1919. They also lived in Allendale.

Another aunt, Clara Buthfer, married Clarence Cooper and had one daughter, Anna Elizabeth, born July 1914.

We walked two miles to school, church, Sunday School, and Epworth League, which was at the Archer Memorial Church. Dr. Charles Woodruff was the minister at Archer Memorial Church from 1911 to 1925, then retired to Ocean Grove. He baptized me at less than a year old, received me into the church in the spring of 1922, and remarried Theodore Roosevelt Myer and me on January 2, 1931 in Ocean Grove, NJ.

Theodore R. Myer was the son of Lottie Harris Myer, a nurse for the J. Winter family for many years. He graduated from Allendale Grammar School in 1923 and also attended Ramsey High School. He worked for the Harry Morris Plumbing business.

We married young, and Theodore and I had 64 happy years going through the depression taking care of ourselves and our three children: Theodore Richard Myer (b. September 4, 1931, d. April 24, 1935), George Henry Myer (b. December 25, 1937 and lives in Kennedyville, Maryland), and Patricia Lucille Myer (b. March 13, 1941; married Thomas Puerling) who lives in Santa Barbara, California.

After the Second World War we left Stanford, Connecticut, New York, and New Jersey, and travelled the country. We settled in Santa Barbara,

California in 1948 and have been here ever since. Theodore Roosevelt Myer d. August 6, 1992 at 82 years. Next to Allendale, New Jersey, I love Santa Barbara, California. ■

From *The Argus*, July, 1927 [or 1925?] — Frank Horak, who tried for second place point honors with Rosemary Hartt, Allendale's girl speed marvel, is another borough boy who promises to bring more credit to his home town in the future. Already Frankie has built a reputation for himself on the scholastic diamond, and the way in which he handled "short" for the grammar school this

year will be a mark for a lot of lads to shoot at in years to come. Frankie ran away with the first place in the 75 yard dash for boys under 16 years of age.

In the standing and running jump events Frankie garnered two second place medals, placing him second in the point rating to tie with the fleet Rosemart Hartt who captured two firsts in the events for girls. Young Horak will be a welcome addition to the talent at Ramsey High where he starts in the fall, having just graduated from grammar school here.

Rosemary, it is said, is for "remembrance" but in Allendale on July Fourth Rosemary was for speed, and a brand of speed that will be remembered for some time to come. Rosemary Hartt of Crescent Avenue, who tied with the blonde Frankie Horak for second point prize at the athletic games last Monday, is a wee miss who will bear watching as she goes through high school at Ramsey. Already Rosemary has shown speed which could be developed by proper training and coaching and has time and again, in local school contests, fairly walked away from her rivals in the dashes.

On Monday, Rosemary started from scratch in the seventy-five yard dash for girls, against a field of six, all the other entrants being granted a handicap start of three yards. In spite of this the Speed Queen of Crescent Avenue breasted the tape a full twelve yards ahead of her nearest competitor. Such speed in a girl of her years is nothing short of marvellous and it will be regrettable indeed if she is not taken in hand and properly trained for the bigger meets in the scholastic leagues of this state.

ALLENDALE HOUSES BUILT BEFORE 1940

Compiled by Pat Wardell

Compiler's Note: This "inventory" of pre-1940 Allendale houses has been compiled using information in the Society's files and in my own files. Very few of the houses have been systematically researched, so we know that for most of them, the information is incomplete. We would welcome any additions, corrections, updating, etc. from our readers, and will happily add such information to the Society's files.

Only houses still in existence today are included in this inventory. Houses are generally named for the earliest known owner/occupant. Names associated with a house are not necessarily always owners; some may have been tenants. Also, not all owners actually lived in houses they owned; some houses were leased for rental income. The houses are listed alphabetically by street names, then numerically by house number.

475 Franklin Turnpike Fell-Ackerman-Cable House (Continued) Block 1809, Lot 14 (Old Block 35, Lot 44)

Some residents and owners of this house and their part in its building history

John Fell, a figure in local, state and national history, was born in New York City in 1721. He ran a merchant firm there. Fell purchased land in what is now Allendale sometime before 1769. Traditionally, the south half of the center block of the house at 475 Franklin Turnpike is attributed to John Fell around mid-18th century. However further inspection is necessary to determine if the house was built before Fell acquired the property. Erskine's Revolutionary map of this area shows that a non-extant road bent to the northwest in front of Fell's house (probably then the route of the circa 1750 Albany Post Road, west of and parallel to the 1806 Franklin Turnpike). Thus the south-facing portion of the house stood on the east side of the Turnpike until the road was chartered and laid out in 1806. This house is one of two Allendale buildings that existed along this older post road; the other is the Ackerman-Rozmus House at 70 Franklin Turnpike.

Fell sold his property to John Thompson in 1793 and moved to N.Y. State where he died in 1798. Local tradition attributes the 2nd story of the south central portion, and the east wing, to him. Tradition says Thompson was a war profiteer, but more research is needed on his part of the house's construction history. Physical inspection dates the 2nd story of the south central block and the east wing to the late 18th-early 19th (c. 1810) centuries.

There may have been other owners between Thompson and John G. Ackerman. The 1861 map

and local tradition place the latter as a mid-19th century owner of the house.

Ackerman was host to Colonel Joseph Warner Allen, who between 1846-1848 surveyed the proposed route of the Paterson and Ramapo Railroad through this part of what was then Franklin Township. By 1850, the tracks were completed and a depot (no longer extant) was built in Allendale on the east side of the tracks, diagonally opposite the present station's site. The railroad stop was named Allendale in honor of Colonel Allen.

Stephen Cable (born c. 1815, died 1887) was the next owner of the house. Cable was the Ferry Master for the Erie Railway Co. on the Pavonia Ferry. Cable's family had a significant part in the ecclesiastical history of Allendale. Beginning in 1872, Mrs. Cable held Sunday School classes in her home. It is believed that these gatherings were held in the east wing. Interest in the group increased and larger meetings were held in the Cable's barn north of the house. In 1876, the board -and-batten "Chapel in the Willows" was built for the congregation, almost directly across from (east of) the Cable's house. In 1894, the Chapel was moved to its present location at the northeast corner of East Orchard Street and Franklin Turnpike, where today it serves a Presbyterian congregation.

Jean Paul Pfister told representatives of the Bergen County Sites Survey team that early 20th century additions/alterations were made to the 475 Franklin Tpke. house around 1912 by the Taylor family. Additions included the north half of the center block and the west wing/veranda unit. The west wing is a design of mixed Colonial Revival/Dutch Colonial features. It has an attractive sweeping gambrel roof over the west veranda. The exterior clapboards of the older house may have been replaced around this time, as they match those on the 1912 west wing. Early 20th century additions to the property include cobblestone walls northwest of the house.

John Fell was a descendant of Symon Fell, a Huguenot from Dieppe, France, who in 1655 was living at New Amsterdam. John Fell was born in New York City on February 5, 1721 and attended public schools there. He married on December 2, 1749 in New York City (Trinity Church), Susannah Marshalk, widow of a man named Mackintosh (McIntosh). He was senior member of the firm Fell and Graham, doing business as traders and merchants at 2 Crugers Wharf, on the East River, New York City. He is said to have been engaged in trade by river boat on the Hackensack and Passaic Rivers, contacting the mills on the old Demarest tract and stopping at the Demarest Inn (on Franklin Turnpike, in what is today Ramsey) in the course of his business with the grist mills of the area.

By 1759, Fell was the senior member of the merchant firm of John Fell & Co., in New York, at which time the firm had several armed merchant vessels engaged in overseas commerce. About 1756, John Fell obtained a tract of 220 acres, being 32 chains by 69 chains in area, at "Paramus" in what is today Allendale. ["Paramus," the name given to a settlement surrounding the Paramus Church, at that time encompassed a much larger general area.] The boundaries of this original tract of land are discernible today on the Tax Assessment Map of Allendale, although the tract has been greatly subdivided in subsequent years. Fell named his estate "Petersfield," probably after his son, and his house stood on the site of the present house at 475 Franklin Turnpike. It is highly probable that this present house incorporates either Fell's original house or the foundation of it, as portions of the existing house appear to be of Revolutionary or pre-Revolutionary age, and one of the older rooms in the house employs ship's masts as supports.

John Fell was appointed, on September 30, 1766, a Judge of the Court of Common Pleas of Bergen County, in which capacity he served until 1774. He was an ardent supporter of the rebel cause and on June 25, 1774 he was the leader at a meeting of 328 Bergen County citizens who signed patriotic resolutions at the Court House in Hackensack. He was a member of the First Provincial Congress which met in Trenton in May, June, and August 1775, and in 1776 was chairman of the Provincial Council. On September 6, 1766 he was again appointed a Judge of the Court of Common Pleas of Bergen County and he served in this

position until 1786.

Because of his great patriotism and his reputation as a "great Tory hunter," on April 22, 1777 Fell was taken prisoner at his Allendale home by a band of 25 armed Loyalist raiders, and hurried to Bergen Point, where Colonel Abraham Van Buskirk was in command of the British forces. Fell and Van Buskirk had known each other before the war and when Fell was brought before Van Buskirk, the Colonel gave him a letter to General Robertson, in New York, which Van Buskirk claimed would insure proper treatment for Fell. Fell was taken to New York and confined in the provost jail, where he underwent harsh and severe treatment. Apparently General Robertson did not see Fell until December 8, at which time Fell presented Van Buskirk's letter to the General. Robertson read the letter with a curious smile and handed it back to Fell. who discovered that the essence of the letter was that "John Fell was a great rebel and a notorious rascal." As it happened, Fell and Robertson had made each other's acquaintance years before, during the French War, and the General said, "You must be changed

indeed, John Fell, if you are as great a rascal as this Colonel Van Buskirk." Fell was paroled on January 7, 1778 and was finally permitted to go home on May 11, 1778.

On November 6, 1778 John Fell was elected by the New Jersey Legislature to serve as a New Jersey delegate to the Continental Congress. He was reelected May 25 and December 25, 1779. He attended Congress steadily from Dec. 5, 1778 to November 28, 1780, during which time he cast 256 votes. Her served on various special committees, but his main work was on a standing committee of five to conduct the commercial affairs of the United States. He voted steadily for economy, sound finance, and the increase of national authority. While serving in Congress, Fell kept a diary from November 6, 1778 to November 30, 1779, the original of which is in the Library of Congress. (The diary was printed in book form in 1973 as Delegate From New Jersey: The Journal of John Fell, edited by Donald W. Whisenhunt, published by the Kennikat Press, Port Washington, N.Y.) During 1782 and 1783 Fell served as a member of the New Jersey Legislative Council. His name appears on the Tax Rateable Lists for Franklin Township in Bergen County in 1779, when among his holdings were listed 220 acres of land, 14 horses and cattle, and a riding chair. He is found in the Rateable Lists in subsequent years (in 1791 his holdings included 160 acres of improved land, 60 acres of unimproved land, 2 horse, 9 homed cattle, a riding chair, and a pleasure sleigh) until 1793 when, on November 1, he sold his estate to John H. Thompson of New York City.

Fell moved to New York City and subsequently to Coldenham, New York, where he died on May 15, 1798 at the age of 77 years and 15 days. He is buried in Coldenham Cemetery.

John Fell and his wife Susannah had at least three children: Peter Renaudet Fell, Susannah Fell, and Elizabeth Fell.

Peter Renaudet Fell, son of John and Susannah Fell, was born about 1752, and was a Lieutenant Colonel of the First Regiment of Bergen County Militia during the Revolution. After the war he became hopelessly crippled with rheumatism and he retired to Coldenham. N.Y. where he died on October 6, 1789 at the age of 37 years. He had married in 1781, Margaret Colden, daughter of Cadwallader Colden and Elizabeth Ellison. and granddaughter of Lieutenant-Governor Cadwallader Colden of New York. Their children were: Elizabeth Fell, born in N.Y. (married her cousin, William Colden); John Fell, born in New York (married and had children); and Susan Fell, born at Paramus (probably at John Fell's Petersfield Estate) (married Charles Rhind). Peter R. Fell's widow, Margaret Colden Fell, married as her second husband, Peter Galatian (Gallatin).
