Allendale residents who have a personal computer and a modem now have access to the catalog of the Bergen County Cooperative Library System from 9 p.m. to 9 a.m. weekdays, and from 6 p.m. until 9 a.m. Saturday and Sunday. Also available during these time periods is the UMI Periodicals Research I database which indexes approximately 1000 general interest periodical titles. Approximately 350 of these titles are now available on-line in ASCII full text format. A valid library card is needed to access these databases.

The generosity of the Friends of the Library has bought us Moody's Company Data on CD-ROM, Magazine Express with coverage from 1988 to the present on CD-ROM, the Record on-line, and the Rental collection.

School Board Election - Tuesday, April 16 from 1 to 9 pm.

Allendale's Senior Citizen low and moderate income homes are now being built at the modular factory in Pennsylvania. Delivery to the site in Allendale is planned in May. There will be eight buildings, each containing two residences. Fifteen will be rented and one used as a meeting place.

Our contractor, VMH Construction of Mahwah, will begin constructing foundations on site this month. Construction schedules call for completion not later than August 1.

Operation of the rental housing will be handled by Presbyterian Homes Foundation, operators of Senior Housing in Ramsey. Presbyterian Homes will begin reviewing applications in May of this year for occupancy in September. If you are 62 years old, with an income of not more than approximately \$25,000 for one or \$28,000 for two persons, you may be eligible. Rents are expected to be about \$600 a month, plus utilities. Non-residents may apply.

1996 MUNICIPAL BUDGET

TOTAL TAX RATE MAY INCREASE 5% FOR 1996. MUNICIPAL RATE MAY BE UP 10%

The recently introduced Allendale municipal budget for 1996 calls for a 10% increase in the municipal tax rate. When combined with increases for schools and a reduction in the County rate, the increase in tax rate paid by Allendale taxpayers is expected to be less than 5%. A 1996 rate of \$2.37 would increase taxes by \$110 for each hundred thousand dollars of assessed value.

The tax increase is entirely due to an unexpected \$900,000 reduction in State Aid. The \$900,000 loss, when reduced by a \$26,000 saving in budgeted expenditures and by the use of an additional \$325,000 of Surplus, leaves a planned tax increase of \$563,500.

The Borough will apply for 1996 Discretionary Aid. Any Aid granted will be used to reduce this year's tax increase.

Salary and wages cut \$86,000.

An \$86,000 reduction in salary and wages will come from:

- not replacing two policemen, reducing the uniformed patrol force to ten officers. Elimination of two school crossing guards is also expected.

- holding salary increase for fulltime staff to 3% while eliminating increases for part timers.

Operating Expenses increase \$66,000.

- Northwest Bergen Sewer Authority charges are up \$77,500.

- \$20,000 for sewer engineering to reduce NWBSA charges.

- Snow removal is up \$24,000 because of recent storms.

To reduce the impact of these increases, we have cut:

- the contribution to the Library by \$21,000.

- the contribution to the Ambulance Corps by \$15,000.

- \$25,000 for the repair of the upper dam at the lake.

- \$7,800 from the budget of the Fire Department.

- \$10,000 in contributions to Visiting Nurses, Drug Addiction and Aid to Health Care programs.

- \$13,700 from the departmental operation budgets.

Improvements not funded in 1996

We will use \$60,000 left in the Capital Improvement fund to provide the down payment on \$600,000 of 1996 expenditures for paving roads, purchase of equipment, repair of dams at Crestwood and improvements to recreational facilities including repair of the Ballpark Grandstand.

Reserve for Uncollected Taxes

If it were possible to budget this Reserve at normal levels, we could hold the increase in the Municipal rate for 1996 to less than 5% and the increase in the overall rate to 3.5%.

Future discussions of the budget_

The budget will be discussed in detail during the budget hearing, before adoption, now scheduled for the Borough Council meeting to be held on Thursday, March 28. A summary was published in the Ridgewood News on March 14th. The full budget is available from the Borough Clerk.

Please come out for the March 28 meeting. The Council welcomes your suggestions for reduction in expenses and your comment on the reductions that are planned.

DID YOU KNOW?

A change in the New Jersey Motor Vehicle Law (R.S. 39:3-46 & R.S. 39:3-47) now requires head lamps "whenever rain, mist, snow or other precipitation or atmospheric moisture requires the use of windshield wipers by motorists".

Failure to use lighted lamps when lights are required may result in a fine not to exceed \$50.00.

COMPOST SITE

The site will open on Saturday, April 6th, close on Easter Sunday, and reopen for the season on April 13th. New applications for permits will be mailed to residents in March. The fee for the 1996 permit will once again be \$25. These permits are required for grass clippings and yard waste such as leaves and brush. COUNCIL TO DECIDE ON ALLENDALE'S FUTURE WATER SUPPLY

The Council is currently discussing solutions to Allendale's water problems. We urge you to attend our meetings to learn about the alternatives considered in our efforts to insure Allendale of an adequate supply of water in future vears.

There are members of the Council who consider this is the most important decision the Council will make during their term as a Councilman.

Questions about whether to fully develop all of Allendale's wells or to buy more water from other towns instead, the quality of the water, quantities of water, and relative cost must be resolved. Join us to help make the decision.

WATER RESTRICTION SCHEDULE EFFECTIVE MAY 1ST

In order to assure sufficient water for domestic use, fire fighting, and lawn watering, the Borough has established а three-phase restriction program. Phase I is being instituted on May 1st. Should water demand exceed production capabilities, you will be notified of Phase II restrictions. In the event of excessively high demand, and a reduction of supply from the Borough of Ramsey and Mahwah Township, residents will be notified when Phase III will be implemented. Water conservation is important for all of our residents. Your cooperation is essential to prevent further restrictions.

PHASE I - Odd/even lawn watering. Those with an odd number street address may water at any time during an odd numbered day. Those with an even number street address may water at any time on an even numbered day.

Hand-held hose watering or car washing is allowed at any time.
