# ALLENDALE HOUSES BUILT BEFORE 1940

Compiled by Pat Wardell

Compiler's Note: This "inventory" of pre-1940 Allendale houses has been compiled using information in the Society's files and in my own files. Very few of the houses have been systematically researched, so we know that for most of them, the information is incomplete. We would welcome any additions, corrections, updating, etc. from our readers, and will happily add such information to the Society's files.

Only houses still in existence today are included in this inventory. Houses are generally named for the earliest known owner/occupant. Names associated with a house are

not necessarily always owners; some may have been tenants. Also, not all owners actually lived in houses they owned; some houses were leased for rental income. The houses are listed alphabetically by street names, then numerically by house number.

583 Franklin Turnpike Peinecke House

Block 911, Lot 15 (Old Block 35, Lot 28)

Built 1920.

This house was connected to the Van Houten House, Block 911, Lot 7 (589 Franklin Turnpike) and at one time the two houses were probably on one lot. This house now has access from Franklin Turnpike via a 10-foot right of way along the south side of #589 Franklin Turnpike.


In 1940 the house was described as a one-and-a-half story frame dwelling with a sun porch on a 111 foot x 345 foot plot. It had a poured concrete foundation, a wood shingle exterior, and a composition shingle roof. There were seven rooms, including 3 bedrooms and one bath.

# 589 Franklin Turnpike Van Houten House

8 July 1926, Ramsey Journal — Mr. and Mrs. Oscar Peinecke, of Ridgewood, have moved into the house on Franklin Turnpike, formerly occupied by Mr. and Mrs. S. T. Van Houten, Jr. [Mrs. Peinecke was the former Grace Van Houten.]

31 Jan 1929, Ramsey Journal — Mr. and Mrs. Stanley Fisher of College Point, Long Island, expect to take up their residence in this borough about February 1st, occupying the Van Houten house on Franklin Turnpike. [Mrs. Stanley Fisher was the former Anita Van Houten.]

28 Apr 1938, Ramsey Journal — Mr. and Mrs. B. J. Goode of West Crescent Avenue will move into the apartment of Mrs. S. T. Van Houten, Sr., of Franklin Turnpike, on or about May 15. The residence of Mrs. Van Houten is being remodeled into a two-family apartment. [This item probably refers to the Van Houten house at #527 Franklin Turnpike.]

This house and the one further south on Franklin Turnpike, at no. 527, were both owned by S.T. Van Houten and some of the data for them may be confused.

Until 1942, this house and lot was appraised and apportioned with Block 1809, Lot 19 (Old Block 35, Lot 36), just north of this house and lot.



Stephen Terhune Van Houten (Sr.) was born in New York City April 29, 1866 (died June 1936), the son of Jacob Henry Van Houten and Hannah Matilda Terhune. He married Georgianna Schneider, born in New York City (died 1943), the daughter of John Schneider. Mr. Van Houten was a department manager for Claflin's wholesale dry goods firm and served on the Allendale Board of Education. Mrs. Van Houten was active in the Ladies Village Improvement Association and later the Woman's Club of Allendale. She was one of the Ladies V.I.A. committee instrumental in starting the Allendale Library in 1900, and later signed the Library certificate of incorporation (in 1923).

Stephen T. Van Houten and his wife, Georgianna Schneider had children: Anita Van Houten, b. March 6, 1892, d. Jan. 1972 (m. Stanley P. Fisher); Stephen T. Van Houten, Jr., b. about 1893, d. January 1977 (m. Marion F. Taylor); Matilda Van Houten (m. George Linke); Grace Van Houten, b. abt. 1896 (m. Oscar Pienecke); Georgianna Van Houten, b. abt. 1902-03, d. Nov. 1982 (m. Melvin R. Lane).

## 625 Franklin Turnpike Christopher House

Block 910, Lot 15 (Old Block 40, Lot 13)

#### Built 1927.

J. Muried Christopher and Ada M. Christopher, 1927-1967.

— 25 Aug, 1927, Ramsey Journal — J. M. Christopher and family have moved into their new home on Franklin Turnpike and Ivers Place.


In 1940 this house was described as a two story frame dwelling with a sun porch and a garage. The buildings stood on a plot with 183 feet of frontage on Franklin Turnpike. The house had a poured concrete foundation, a brick and clapboard exterior, and a composition shingle roof. There were 7 rooms, including 3 bedrooms, one half-tile bath and a lavatory. There was a finished laundry in the basement.

When the house was for sale in 1975, an ad from the *Ridgewood News*, Sunday, March 9, 1975, described it:

ALLENDALE--625 Franklin Turnpike. A landmark and a classic, 4 bedrooms, 2-1/2 baths, Dutch Colonial, built in 1927 on 1-1/2 acres. 2-story mini Carriage House could be used for many purposes. \$115,000.



Jacob Muried Christopher was the son of Richard Christopher and Anna Maria Green Ackerman. He was b. 15 Feb 1879 Allendale; d. 18 Oct 1966; buried George Washington Memorial Park, Paramus, NJ. He married (1) about 1907 Ada Mallinson, daughter of William Henry Mallinson and Mary Ella White. She was b. 31 Oct 1882; d. September 1955. J. M. Christopher m. (2) 15 Sep 1956 Helen R. -?-, widow of John Abram Ackerman.

He was a grocer at the time of the 1900 Federal Census, single, and living with his parents. He was in partnership with John Winter in the early 1900s in a grocery store on West Allendale Avenue in Allendale, trading as Winter & Christopher. He later owned the Allendale Coal and Lumber Corporation at 55 Park Avenue, Allendale. He was the first treasurer of the Allendale Fire Association and a charter inactive member of the Association in 1910. He was a charter vice president of the First National Bank of Allendale in 1925 and one of its directors. He was a director of the Citizen's First National Bank and Trust Co. in Ridgewood.

He owned a number of houses as rental income properties in Allendale, including houses at 34 Maple Street (1940), on West Orchard Street, at 53 New Street (house built about 1955), on Woodland Avenue, and on Park Avenue.

He also owned, in 1940, with his brother, R.J. Christopher, rental income houses at 25 Oak Street (built about 1925), 35 Oak Street (built 1934 and sold to William and Marion Lightweis 15 Sep 1944), 1 Walnut Place (built about 1925) and 24 Walnut Place (built 1928). In 1940 they also owned the houses at 242 Park Avenue (built about 1905) and 246 Park Avenue (built about 1910; in 1940 its assessment also covered the sawmill).

J. M. Christopher and his first wife, Ada Mallinson, had a son, Olin Muired Christopher, who m. Mary Eva Durland.

**634 Franklin Turnpike Legg (?)-Appert House**Block 801, Lot 19.1 (Old Block 53, Lot 110A)

21 Sep 1894, *Bergen County Democrat* — Albert Legg has purchased about three acres of land from Mr. Ivers, and is grading the property prior to the erection of a substantial residence.



Albert Legg was born about July 1854 in New York and married Abbie G. -?-. She was born about May 1856 in MA. By Sep 1894 he had bought three acres of land from A. E. Ivers. They were living on or near Franklin Turnpike at the time of the 1900 Federal Census, probably in the house at 634 Franklin Turnpike, built for him about 1894-1895.

He was an inventor. One of his inventions appears to have been a self-threading sewing machine needle. Correspondence about this invention, dating from 1897 to 1900, was found in the attic of the Burtis house at 262 Brookside Avenue by Mrs. J. Bennett Monaghan (Mary S.), who lived there from January 1951-?. How these letters came to be in the attic of this house is not known, nor is the relationship (if any) known between the Burtis family and the Legg family.

In the 15 Dec 1894 issue of The Souvenir, published by the Archer ME Church, it was noted that "Mr. A. E. Ivers has recently made a sale of land to Mr. Legg, on which the purchaser is building. By June 1895 R. Nimmo had moved into the house recently occupied by Mr. Legg, who had moved into his new house built on a lot purchased from Mr. Ivers.



Henry John Appert, Jr. ("John"), was the son of Henry J. Appert (who developed the Allendale Produce Gardens, later known to Allendale residents as "the celery farm") and Ella B. Finn. Henry John Appert was born about Feb 1891 and married about June-July 1916 Lillian H. McClauggey. In 1916 he worked for the Standard Oil and Gasoline Co. at Bayonne. He was elected president of the Allendale Fire Department in December 1940.

1996 Historic Holiday C)rnament Available through Archer Church

The Allendale Hotel (circa 1905) is featured on this year's limited edition holiday ornament. The 3-1/2-inch glass ornament is glazed bisque in color with forest green graphics and lettering, and shows the Hotel as it looked in the early part of this century. The graphic rendering was done by Allendale artist Frank Vitale.

The ornaments sell for \$10 each and are available at the office of the Archer Church and at a number of local shops which support this benefit for Archer Church and the Historical Society. This is the third ornament in a series that highlights scenes of Allendale's past. Archer Hall was on the first year's ornament, and the coal hopper that was recently torn down to make way for Orchard Park condominiums was featured last year. A limited number of previous years ornaments are still available at \$5 each.

The ornaments are presented in a display/storage box. They are also suitable as a gift item and can be shipped parcel post for you for an additional \$3 per order through the Church office at 201-327-0020. Twenty percent of the net proceeds from the sale of ornaments is donated to the Allendale Historical Society by Archer Church.
